MINNESOTA STATE COLLEGES AND UNIVERSITIES* ARTICULATION AGREEMENT BETWEEN

ANOKA-RAMSEY COMMUNITY COLLEGE AND UNIVERSITY OF NORTHWESTERN – ST. PAUL

*The Board of Trustees of the Minnesota State Colleges and Universities is authorized by Minnesota Statutes, Chapter 136F to enter into Agreements and has delegated this authority to colleges and universities.

This Agreement is entered into between ANOKA-RAMSEY COMMUNITY COLLEGE (hereinafter sending institution), and UNIVERSITY OF NORTHWESTERN – ST. PAUL hereinafter receiving institution). This Agreement and any amendments and supplements, shall be interpreted pursuant to the laws of the State of Minnesota.

The sending institution has established an ASSOCIATE IN FINE ARTS: MUSIC, and the receiving institution has established a BACHELOR OF ARTS IN MUSIC, and will facilitate credit transfer and provide a smooth transition from one related program to another. It is mutually agreed:

Admission and Graduation Requirements

- A. The receiving institution's admission and program admission requirements apply to both direct entry students and to students who transfer under this agreement.
- B. Students must fulfill the graduation requirements at both institutions.
- C. Students must complete the entire sending program and meet the receiving institution's admission requirements for the agreement to apply.

Transfer of Credits

- A. The receiving institution will accept **41-66** credits from the sending program. A total of **79-84** credits remain to complete the receiving program.
- B. Students must earn a grade of C- or better for credits to be transferred to receiving institution.
- C. Courses will transfer as described in the attached Program Articulation Table. For system institutions, once the courses are encoded, they will transfer as described in the uSelect Audit.
- D. Students must meet all graduation and transfer requirements, as specified in the receiving institution's catalog.

Implementation and Review

- A. The Chief Academic Officers or designees of the parties to this agreement will implement the terms of this agreement, including identifying and incorporating any changes into subsequent agreements, assuring compliance with system policy, procedure and guidelines, and conducting a periodic review of this agreement.
- B. This Articulation Agreement is effective on 9/1/2014 and shall remain in effect until the end date of 9/1/2019 or for five years, whichever occurs first, unless terminated or amended by either party with 90 days prior written notice.
- C. The college and university shall work with students to resolve the transfer of courses should changes to either program occur while the agreement is in effect.
- D. This Articulation Agreement will be reviewed by both parties beginning 4/1/2019 (within six months of the end date).
- E. When a student notifies the receiving institution of their intent to follow this agreement, the receiving institution will encode course waivers and substitutions.

Students are encouraged to talk with a UNW Advisor to determine what and how many credits will transfer. UNW Transfer Policies:

- Transfer students enrolled in bachelor's or associate degree programs must earn the final 30 credits from Northwestern.
- A minimum of 50 percent of major and minor course work must be completed from Northwestern.
- Course work earned at other post-secondary institutions may be accepted by University of Northwestern subject to review
 and approval by the Registrar.
- Course work with grades of "C-" or higher may be transferable to Northwestern and applied to a Northwestern academic program to the extent that they fit degree or certificate requirements. (Note: Only the credits, not the grades, of transferable courses may be applicable.)

UNW Music Transfer Policies

- All transfer music major applicants must go through the Music Audition Application process (including the Online Theory Placement Exam) in order to be admitted (see www.unwsp.edu/music)
- · At least fifty percent of the required ensemble credits for a music major/minor must be completed at UNW.
- The number of applied lesson credits accepted by UNW will be determined after one semester of applied lessons at UNW.
- Transfer credit for coursework in music theory or sight singing / ear training will be accepted only by placement exam. This
 policy applies to both transfer applicants and current UNW students. Transfer credit and/or placement in the UNW theory
 and sight singing / ear training sequence will be based on the applicant's performance on the exam.

UNW Core:

 The number of Core Credits needed for completion will vary depending on what MnTC courses ARCC students choose to complete. Some MnTC courses may be the equivalent of UNWSP Oral Communication, Social Sciences, Fine Arts, Literature, Mathematics, and/or Lab Science requirements.
